FROM THE PRESIDENT - Michael Hinchman

After many years some of our publicly elected officials are finally addressing budget structural problems. Exhibit A in my mind is Governor Chris Christy of New Jersey. Direct, blunt and informed are the only way to characterize his style. He is one of the first politicians I have seen from either party who "walks the talk." There are many issues he is focusing on: pension reform, health care contributions by our public employees, including teachers, salary increase limitations and those under the table "goodies" for some public officials. Locally, he has seen enough of Atlantic City's operations to gain oversight of the municipal budget in exchange for a waiver of the old cap that Atlantic City couldn't meet. I wish he would go after the Atlantic City public schools which charge its sending districts \$22,000 per student as compared to Ocean City's charge of \$18,000 per student when Ocean City has some of the highest paid teachers in the state. Where is the money going in the Atlantic City public schools you ask?

What does this all mean for Ocean City? It will help Ocean City as the upcoming budget process gets underway. Having said that, public officials in Ocean City believe they are doing a good job as the four (4) percent cap in past years was achieved and early indications are the two (2) percent cap for 2011 will be quite manageable. This viewpoint by Ocean City officials ignores the math that Ocean City has long enjoyed. The city provides services for a two and half (2 $\frac{1}{2}$) month summer season while enjoying the tax base for twelve (12) months. Think about it. When you give a raise to the police department, for example, it is not a four percent (4) raise on the summer staff level of one hundred (100) policemen but on the fifty nine (59) year round officers. The same holds true for public works which also "flexes up and flexes down". Four (4) percent on one hundred (100) officers is substantially more than a four (4) percent raise on fifty nine (59) officers. Ocean City public officials, of course, ignore this math.

Should we be satisfied if the Phillies finish ten (10) games above five hundred (500) or is it more reasonable for them to always make the playoffs and advance given their level of talent and salary structure?

This is our challenge - to awake long sleeping taxpayers on the real math. My fear is a two (2) percent cap for Ocean City will lull everyone to sleep without making our public officials properly accountable to the real budget scorecard.

OUR GOVERNMENT

The typical American household made less money last year than the typical household of a decade ago. After adjusting for an inflation rate of twenty nine (29) percent the U.S. Census Bureau reports that during the last decade, the median household income fell to \$50,303 in 2009. In 1998, the median income was \$51,295 an approximate two (2) percent drop.

During this same period Ocean City employees saw their income increase by fifty-five (55) percent compared to the average taxpayers who saw their income increase by only twenty-nine (29) percent. This indicates that since 1998 our city employees received incomes ninety (90) percent higher than the average taxpayer.

Our city employees are being paid more than the taxpayers. How can our elected officials expect the average taxpayer to pay for salaries that are higher than we are paid in the private sector?

Our founding fathers established a government that was to be: of the people, by the people and for the people. It turns out that our past and current city officials think that we the people, the taxpayers, are a people for the government, and that we are expected to be subservient to the government.

HEALTH CARE

New Jersey public employees benefit system must be aligned closer to the private sector employee benefits. Governor Christie has proposed that public employees contribute one and one half percent (1.5) of their salary, (the average salary for full time employees in 2009 was approximately \$79,676), toward the cost of their health benefits. This would mean that an Ocean City employee would contribute approximately \$1195. The amount private employees will be asked to contribute toward their health care premium is approximately \$2567.

HISTORY

Fairness In Taxes has consistently advocated for a more affordable and effective government. Remember back in 2003 when our elected officials said we had to increase our taxation by fourteen (14) percent and that a full time staff of two hundred ninety one (291) was necessary. At that time Fairness in Taxes and the taxpayers of Ocean City recommended a lower increase in the tax rate be accomplished by reducing the payroll by ten (10) percent. Our local officials, who warned all of us of the doom and gloom that would befall our city if we reduced the number of employees, unfortunately disregarded our pleas and adopted a budget without any reduction in taxation or in the workforce. As you can see in the table below the workforce has since been reduced. If the concerns and suggestions of Fairness in Taxes and the five hundred (500) citizens of Ocean City who gathered at the Music Pier had been heeded, the Ocean City government could have saved the taxpayers millions. There is still much work to be done in all areas of the budget. Hopefully, our officials will start the budget process early and listen to our suggestions for the upcoming budget and perhaps all of our taxpayers will not see an increase in taxes.

THE CAP

Will it be good enough to reign in free wheeling local Governments??

Our new Governor, Chris Christie has proposed a two (2) percent cap that would give exemptions for debt, health care, pension costs, natural disasters or rising school enrollment. Voters would have a say on exceeding the cap by a simple majority of fifty (50) percent.

Sound familiar? In 2006, Fairness In Taxes proposed an Ordinance to cap the Municipal budget that was tied to the Social Security annual increase. The voters would have a say on exceeding the cap by a simple majority of fifty (50) percent. This ordinance was rejected by City Council. In fact, the City of Ocean City went to court to prevent the taxpayers the right to determine how much taxes they should pay. Our proposal was more restrictive than that the proposal by Governor Christie. If our local elected officials had accepted our proposal we would have been able to reduce taxation and would have developed a more efficient and affordable government. As usual, it always comes down to whether our elected officials represent we the taxpayers or are they protecting an inefficient government. The Governor's proposal is a step in the right direction but might not go far enough in developing a lean and efficient government. We will continue to monitor the developments.



OCEAN CITY OVERVIEW

The following information* reflects the financial environment that Ocean City has found itself in:

- As of 2010 Ocean City's population is 14,716 people.
- Since 2000, Ocean City has had a population growth of -4.23 percent.
- ♦ Home appreciation the last year has been -7.69 percent.
- Compared to the rest of the country, Ocean City's cost of living is 62.80 percent higher than the U.S. average.
- Ocean City public schools spend \$11,613 per student.
- The average school expenditure in the U. S. is \$5,678.
- There are about 9.9 students per teacher in Ocean City.

INFRASTRUCTURE

Over the past seven years Fairness in Taxes has occasionally conducted a survey to determine our members concerns. The respondents consistently ranked Taxes as the number one concern followed by Roads and Drainage as being the second most troubling. Over the years we have relayed your concerns to the past administrations. Finally, after many discussions and input from various citizens and community associations we are pleased that, under the leadership of our previous Mayor, Sal Perillo, a study was completed by Hatch Mott MacDonald* to determine the status of our drainage system and how we could best reduce the amount of flooding that the city experiences. The report states: "Most of the city's tide check valves range in age from 10 to 20 years. The inspections revealed that most of the valves are in poor to very poor condition, and some have failed to perform. Tidal flooding occurred during the January 2, 2010 high tide in ten (10) out of the twenty-eight (28) drainage and sub-drainage areas evaluated, confirming that many of the valves in these areas had failed."

This study called for three phases of repairs/replacement/other corrective work and it is imperative that the City follows all of the recommendations made Hatch Mott MacDonald.

"Based on the valve inspection results and the observations during the high tide event of January 2, 1010, the valves in the following drainage areas between Battersea Road and 17th Street are in a failed condition

- North Street (Drainage Area #2)
- ◆ 4th Street (Drainage Area #5)
- ♦ 6th Street (Drainage Area #7)
- ◆ 8th Street (Drainage Area #9)
- ◆ 10th Street (Drainage Area #11)
- 12th Street (Drainage Area #13)
- ◆ 17th Street (Drainage Area #16)
- West 17th Street Bayfront

Additionally, the valves at the following drainage areas were observed to be in poor or very poor condition:

- ♦ Battersea Road (Drainage Area #1)
- ◆ 7th Street (Drainage Area #8)
- ◆ 14th Street (Drainage Area #15)"

Arthur Chew, City Engineer, has advised us that seventeen (17) valves are scheduled to be replaced at an estimated cost of \$295,000.

We would caution all our taxpayers and citizens that is just the beginning of the process to reduce flooding in our city and to increase the quality of life for the taxpayers of Ocean City. We need to remind our elected officials to address the problem. They need to appropriate the necessary funds to continue the needed repairs and upgrades to all of our infrastructure problems.

SENIOR CITIZENS SQUEEZE:

Senior Citizens are affected by the modification of Property Tax Reimbursement Program and the lack of an increase in Social Security Benefits for the second year in a row.

The State Budget for Fiscal Year 2011 contains modifications to the Property Tax Reimbursement Program (also known as the "Senior Freeze"). We suggest you review the state website @ www.state.nj.us/treasury/ taxation/propfrez.shtml, or consult with your tax adviser for further information on how this could effect you.

Our senior citizens will not receive a cost-of-living increase in 2011 Social Security benefits. The Cost Of Living Adjustment (COLA) is intended to preserve the purchasing power of Social Security by increasing benefits to keep pace with consumer prices. In the last year, overall inflation has been low, largely because of the economic downturn and a decline in energy prices. The Congressional Budget Office predicted that inflation would remain low for several years, so Social Security might not pay a cost-of-living increase until January 2013.

EDUCATIONAL REVIEW COMMITTEE - Vic Staniec

Fairness In Taxes Education Committee spent the summer monitoring the capital improvements at the Ocean City Intermediate School. The old leaking roof was replaced with new insulation and a rubber roof. The electric heat was converted to a high efficiency gas HVAC system, which required ductwork to be installed throughout the entire school. The state code mandated that new handicap accessible doors be installed, so every door had to be replaced. The only change order, which cost \$76,000, was to replace the ventilation system in the kitchen, which was not up to present day code. The work was all completed on time and on budget.

The Ocean City School District Business Administrator, Steve Terhune, resigned effective October 31, 2010, in order to accept the position of Business Administrator for the Southern Regional School District, which is closer to his home in Manahawkin, NJ. After an intensive search, Thomas Grossi, the present Business Administrator for the Egg Harbor Township School District, was chosen to replace Mr. Terhune, at a salary of \$124,500 per year. Mr. Grossi is very happy to be able to work in his hometown of Ocean City.

Peter Madden was elected to replace Jay Gillian as president of the Ocean City Board of Education. Although Pete is serving his first term on the school board, he is very active in raising additional funds for the school district, and his hard work was recognized by his fellow board members.

PLANNING & ZONING - Jack Stover

Is it wrong to expect the city planning and zoning functions to maintain and improve the quality of life for those who are residents and those who are property owners of Ocean City? Should all of the taxpayers expect equal access to the "Ocean City" quality of life? Why should the son of a long time resident and graduate of Ocean City High School, have to say that they want to come back East but to the mainland not Ocean City because in Ocean City they can never be sure of what will be done to their neighborhood?

Many residents beyond those who are serving on the Planning and Zoning Boards have spent countless hours addressing the recent changes to requirements for building and maintaining a property in Ocean City and they will be ready for the last set of changes—the Hotel-Motel Zone. However, will Fairness In Taxes

and other community organizations be given the opportunity to provide input before the administration and the committee responsible for formulating proposed changes have taken a position?

Previously, only after positions were taken and local residents voiced their upset was there any respect for their input shown.

Already, the Chamber of Commerce and the Boardwalk Merchants have met with the Committee to shape the Committee's direction. Is this Zone just for their benefit or do all zones in Ocean City make up part of the quality of life for all residents and taxpayers? By ignoring the rest of us the Administration forces us into a posture of being against something rather than being eager to provide positive input to a better proposed segment of the overall plan. Perhaps the reason things are done this way is because the planning is just a façade and a starting point for a half of a dozen or a baker's dozen of variances secured by land use attorneys and or architects and the property owner pays through the nose.
