The Role Fairness In Taxes in the Municipal Election (FIT)

FIT is committed to fostering discussion in Ocean City, In the past the Ocean Community Association (OCCA) and FIT teamed up to sponsor a debate. In 2014 this was not the case. For various reasons, some of which I will speculate on, this was not the case this time around. The reasons could have been; 1) the president of OCCA did nt want to have a debate but preferred a question and answer format instead; 2) a member of the committee organizing the Q & A at OCCA was the campaign manager for the re-election of Jay Gillian and didn't want the Mayor to debate; 3) there is an ongoing attempt to diminish FIT, by some municipal leaders because we challenge them on some actions.

In any event, FIT decided to go it alone and worked with Dave Nahan, Editor of the Ocean City Sentinel and Doug Bergen of OCNJDaily.com. These two professional journalists formulated and decided the questions for the two debates. The Mayoral debate was set for April 7 and the council debate for April 14. Unfortunately, Mayor Gillian was scheduled to be on "vacation" and could not attend.
 We offered any other date in April and he declined.

The April 7 event went on with just the challenger, Ed Price who was subjected to
a one hour and 15 minute Q & A. Likewise, a week later a real Council debate did
take place.

We wish the Mayor had attended, but we believe the process is more important
than any one individual. We thank Mr. Price and the four Council candidates for
attending. Undaunted, we will continue to invite all candidates to debate in the
future.

👔 🖥 Lack of Capital Planning

The most recent episode of choosing to put a skateboard park at the parking lot next to the firehouse at 6th Street exemplifies the poor capital planning in Ocean City,

About 2 years ago (it might have been 3) the City razed the skateboard park at 6th Street & the Boardwalk. Since then other locations have been under consideration. The City faced a deadline for site selection for Green Acres funding in April and a well-attended workshop occurred.

Stepping back, there are several observations: 1) the City razed the old skateboard park without a plan and it took years to decided on a new location; 2) the City at one point in its recent "Capital Plan" wanted to put the new police station next to and above the fire house at 6th Street for \$9 million (which I opposed because of the outlandish price); 3) the parking at this site was promised to the neighbors and is also where the Primary School teachers park; and finally, 4) it became a rushed process in April to meet a deadline.

For other capital projects there are similar instances of poor planning:

- 1) one block of the Boardwalk being redone in 4 years, and then pine chosen which guarantees years of maintenance.
- 2) the now defunct 2nd Street Marina rebuilding.
- 3) the lack of a master plan for the drainage issue.
- 4) the ridiculous overpayment and conflict of interest with the purchase of the 8th Street parking lot.

We will continue to push for better planning—Coming soon is the 2nd Street & Palen Avenue project on the waterfront.

TAXATION WITHOUT REPRESENTION—Jim Tweed

Over two hundred years ago, "taxation without representation" started a revolution. Ocean City celebrates itself as a patriotic town. That is why this is the perfect community to take the lead in a movement for fairness that has long been neglected. Every year it is our good fortune to received millions of dollars in tax revenues from fellow citizens who are not afforded any opportunity to vote for the representatives to decide how much they will be taxed or how those dollars will be spent. The question: why should a community which celebrates our American values tolerate this injustice when it is possible to take action to change it? Opponents will correctly tell you that municipalities do not have the power to expand the franchise. States, however do. Although residency is typically the cornerstone to the right to vote, a growing number of states are delegating authority to municipalities to allow non-residents to vote in some elections. For example, Colorado authorizes municipalities having a population of at least two thousand inhabitants to allow towns like Telluride to give property owners who hold at least fifty percent property interest the right to vote in municipal elections. Connecticut allows any adult citizen who is assessed for taxes of \$1,000 or more the right to vote in municipal elections (although municipalities may limit that right). Other states like Arizona and Montana allow special districts like agricultural, water or power to conduct property-based voting. The core value to all is fairness. Citizens who are most impacted should have a voice in how they are represented.

Opponents will also argue that we should not give non-resident property owners the right to vote because they don't live here and aren't familiar with our local politics. However, my neighbors whose primary residence is Florida or Pennsylvania or other parts of New Jersey follow what's happening in Ocean City closer than some who live here and can vote. It is natural to "guard your own rice bowl," but when you receive most of your rice from others and you don't let them have a say on who gets to eat, that's just plain selfishness.

TAXATION WITHOUT REPRESENTION Cont'd

Ocean City recently held an election and there were several debates or candidates forums. None of the locals asked the question whether any candidate would support a resolution requesting the State of New Jersey to grant municipalities the authority to grant non-residents the right to vote in municipal elections. We did recite the Pledge of Allegiance at each of those programs. I wonder if there are enough Americans living here who would be willing to support "justice for all." If fairness In Taxes does not raise the questions, who will?

FROM THE EDUCATION COMMITTEE—Vic Staniec

After intensive lobbying and negotiations with the Education Committee, Ocean City Business Administrator, Pat Yacobelli decreased the proposed tax increase due from Ocean City tax payers for the 2014-15 budget from 1.65% to 1.5%. While this might not seem like a large amount, it signifies a change in policy. In the past, whenever the Ocean City School District was able to obtain additional State or Federal funding, it would always stash the entire amount in a surplus funds budget rather than applying any of the amount for tax relief. This year \$78,000 is being used to reduce the tax increase due from Ocean City tax payers. This change in policy can be attributed to the constant monitoring the Fairness In Taxes Education committee applies to all School District expenditures and budgeting. The total School District budget for 2014-15 is \$40.9m, of which \$24.68m must be supplied by the tax payers of Ocean City. The remainder of the budget comes from federal and State aid and from tuition charged to the sending districts (Upper Township, Sea Isle City and Corbin City). The School Choice program provides \$2.7m funding from the State. 72.24% of the budget is required to pay for staff salaries and benefits. The Ocean City teachers are the 2nd highest paid in the State of New Jersey, with a mean average salary of \$92,400 per teacher for the current school year.

FROM THE TREASURER – Bill Hartranft

We are still financially solvent, but the dues returns are less than 50% of the membership and considerably less than last year. I would entreat those of you who haven't yet sent your dues to do so. If perchance you don't have our address, it is as follows:

We've spent monies to advertise the debates, fund the debates, including costs for the Mayoral debate that was not attended by Mayor Gillian because of other commitments. As an aside, he was unable to provide an alternate date for a debate with Mr. Price. What was even more unfortunate was that the administration did not allow the airing of the recorded hour and fifteen minutes of non-stop questions presented by Mr. Bergen and Mr. Nahan.


Some of our current activities
